CHAPTER I

INTRODUCTION

A. Background

Education is a process to influence students to be able to adapt as best as possible to their environment and thus cause changes in themselves that allow them to function in community life¹. According to Syaiful Sagala, education is an endless process (Education is the process without end), and education is a process of forming fundamental basic abilities, both in terms of intellectual power and emotions directed at human nature and towards others. Therefore, the learning process is the key to the success of education so that the learning process becomes quality requires quality service management. According to the Law of the Republic of Indonesia Number 20 of 2003, it is defined that education is a conscious and planned effort to create an atmosphere of learning and the learning process so that students actively develop their potential to have religious-spiritual strength, self-control, personality, intelligence, noble character, as well as skills needed by the community, nation, and state. However, the process was slightly disrupted due to the virus outbreak that occurred in Indonesia, including in our province, South Sulawesi, where the virus outbreak was known as covid-19. end of January 2021⁵. The Covid-19 pandemic in Indonesia had a huge impact on the world of education, so the government has made a policy to replace teaching and learning activities that were initially carried out in schools, with online-based learning that is carried out in their respective homes. Distance learning is considered an effective step in the education system to prevent the spread of the virus.

Responding to the above, the government implementing social distancing, which prohibit people from visiting crowded places to prevent the spread of the virus. The application of social distancing alone is unnecessary not enough to inhibit or stop the spread of the virus outbreak, for that the government has now also implementing physical distancing where each person is required to maintain a minimum distance of 1 meter from one another. This is very intensively instructed by Indonesian and world health experts and politicians. This caused the government to issue a work from the home decision, where all work without exception is done from home because if you continue to work in an office or other place it will accelerate the spread of the virus outbreak.

This is certainly a tough challenge for teachers in applying this online learning. At the time of conventional learning, not many of these "special" students wanted to pay attention to and contribute to learning, they already wanted to go to school and were very grateful. Therefore, teachers must work extra hard so that students want to follow this online classroom model. From observations made by researchers during the Covid-19 pandemic, researchers found problems faced by teachers, namely in the process of implementing online classes during Covid-19. These problems arise from teachers and students, such as the independence of students when learning from home online makes students must understand the material presented themselves, then do assignments and report it. Teachers also, because they need to prepare a lot of things as well as planning new lessons for the effectiveness of online learning. Online learning is unusual and certainly challenging for students, but teachers also run into difficulties.
