

This is supported by Circular Letter Number 4 of 2020 concerning the Implementation of Education Policy in the Emergency Period of the Spread of Coronavirus Disease (Covid-19) in pdf format signed by the Minister of Education and Culture Nadiem Makarim on March 24, 2020. The principle applied in the policy during the COVID-19 pandemic is "the health and safety of students, educators, education personnel, families, and the community is a top priority in establishing learning policies". Elementary School is one of the levels of education that feel the impact of the COVID-19 pandemic.

The current pandemic condition requires educators in this case teachers to innovate to change face-to-face learning patterns into learning patterns without face-to-face. It explained that there are other learning models that can be used by teachers as a medium of science delivery, namely online learning and mixed learning (a combination of two learning methods, namely face-to-face and online learning). Online learning methods do not require students to be present in class. Students can access learning through internet media.

Online learning is commonly called e-learning, derived from the word electronic and learning which means learning using electronic equipment. e-learning is the delivery of learning programs, learning using electronic means such as mobile phones, leptops, and computers. Stockley asserts that the word "e" refers to the use of electronic means for learning.

Online learning is a new challenge for educators during the Covid-19 pandemic like this, which requires teachers to be able to strive for various ways to carry out the learning process to achieve educational goals and is expected to

be able to form a positive character for students. So teachers must prepare a good planning, implementation and evaluation of learning.

The existence of teachers as one of the components in the education system greatly affects the results of the teaching and learning process. In the process of teaching and learning teachers also need various facilities and infrastructure that can be used in supporting the online learning process to maximize learning from home (BDR) so that the expected goals can be achieved optimally. These facilities and infrastructure are used by teachers in delivering materials to students.

Warkintin and Mulyadi explained that education is a system that develops a fairly broad mission related to physical development, skills, thoughts, feelings, abilities, social to problems of trust or faith.<sup>3</sup> So that whatever obstacles or obstacles of education continue to run well. The obstacle in this case is the obstacle experienced by teachers in the midst of Covid-19 conditions, learning is carried out online and cannot be carried out face-to-face in class. This condition requires teachers to innovate in the learning process, especially online learning (in the network).

#### **CHAPTER II**

The first research about learning outcomes is conducted by Nurul Astuty Yensy Mathematics Education study program, Faculty of Teacher Training and Education. With the title "The effectiveness of learning mathematics statistika hammering medi Whatsapp Group is reviewed from student learning outcomes (Endemic Period of covid 19). The similarity of the author's research with this study lies in the object, namely the student learning outcome sector during the Covid-19 pandemic. While the difference is that previous research focused on whatsapp group media while this research focused on offline learning.

The second research conducted by Mistawaini with the title "Problems of The Implementation of Islamic Religious Education in Fostering Students in SMPN 2 in Pondok Suguh District, Muko-Muko Regency". Previous research has focused on the problem of Islamic religious education (subjects) in fostering students. While research now focuses on transforming the learning process. Previous research has used a type of qualitative research.

The third research conducted by Khwani with the title "Problems of Islamic education learning and solutions carried out by islamic religious education schools and teachers at SMA Negeri 2 Takalar". Previous research has focused on problems that occur in the learning of Islamic religious education.

While research is now the focus of the learning process English the research equation is sam-sama using descriptive research types with qualitative methods.

The fourth thesis written by Tiara Cintiasi (IAIN Salatiga, 2020) "Implementation of Online Learning Model during the Covid-19 Pandemic in Class III of PTQ Annida Elementary School Salatiga School Year 2020" the results of the research are (1) Implementation of online learning models in class III, namely by utilizing several types of applications such as whatsapp, google form, google meet and kine master to make learning videos, (2) Inhibiting factors in implementing online learning are, lack of effectiveness and time efficiency due to parents of students who are busy with their work so that they cannot accompany their children in the online learning process, (3) supporting factors in online learning, namely, schools facilitate wifi for teachers in schools as a means to provide online learning materials to students, and schools also facilitate students by providing quotas. Free every month. The similarity of research with what researchers do is equally related to learning during the pandemic. While the difference is that the object of research there are other applications, as well as research places.

The fifth thesis research written by Hilwa Putri Kamila (UIN Syarif Hidayatullah Jakarta, 2019) "The effect of Whatsapp Social Media Utilization on The Motivation of Learning Indonesian at Al Wahab Islamic Junior High School Jakarta For the 2018/2019 School Year" the results of this study are the influence of the use of whatsapp social media on the motivation of learning Indonesian

#### **B.** Some Pertinent Ideas

# 1. The Concept of Learning English

#### a. Learning English

Language learning is a long and complex way. Language learning is the steps where the learners explore all their competence to think, feel, and act. In addition, he also states that language learning is not a set of easy steps that can be programmed in a quick kit. It needs regular training in order to succeed in learning process. In relation to learning, he states that teaching is the process of guiding and facilitating learning.

Teaching also enables the learners to learn and setting the condition for learning. It implies that teaching cannot be separated from learning. The teachers' understanding of what learning will determine his or her understanding of what teaching is. Teachers' understanding of how students learn will determine the teacher's philosophy of education, teaching style, approaches, methods, and the classroom techniques. The approach, the methods, and the techniques that are used in the classroom depend on the teacher's understanding

Richards says that language teaching is hence a complex issue, encompassing socio-cultural linguistic, psycholinguistics, as well as curricula and instructional dimensions. Concerning to the foreign language teaching, there are some experts point out that second or foreign language teaching is any activity on the part of one person intended to facilitate the learning by another person of a language which is not his native one. <sup>7</sup>

Based on the statements above, language teaching and learning involves a lot of aspects in order to get a success. Teachers are expected to be able to set the objectives and modify their teaching style in order to accommodate the learners' need.

Learning has been defined by many researcher. learning is the process of interaction of students with educators and learning resources in a learning environment. Learning is a conscious process involving memory associated with information being studied, for example supporting greetings, using language rules, and vocabulary. Language learning is life enhancing.

Tomlinson and Masuhara stated that language learning can use knowledge about language systems and use of language that involves institutions, instructors, learners, and spending also prioritizes learning experiences, self-appreciation, emotional involvement, connected learning with thought power, communicative language use, and learning materials that encourage learners'

Furthermore, Learning can interpreted as an interaction process between learning participants and instructors for learning resource on a learning environment to achieve specific learning goals, and the main principle is the whole process of involvement or a large portion of the students' self-potential.

Additionally, the earlier the children learn foreign language, becomes easier child to master the language. According to Johnson which categorize the knowledge and skills that are considered as communicative skills involved in language usage, competence is the term used by linguists to loosely explain what we have called expertise and capacity so far. Pointedly, the new era and globalization today demand many people to master English as an international language.<sup>8</sup>

Learning English holds prominent functions in many aspects of human life. O'Brien states that more people learning English today in the history of the world because English as important role for human's life to communication. In addition, Learning English means essential for today's generation to adapt to global communication, literature, media, and work in the present and future. Pointedly, learning English is learned very seriously by many people, and realizing that English is important many people want to study because English it will be easy to communicate with other people in the world.

#### b. Objectives of English Learning

English in Indonesia is generally taught as a foreign language for one of the school subjects with the aim of communicating basic and mastering four language skills speaking, listening, reading, and writing. As a language skills, listening is certainly very important similar to other skills.

# c. Component of English learning process

According to Brown there are some components in English learning process in the classroom. They are as follows:

- 1. Attention, is the first step in learning anything. It is easy for most of us to pay attention to things that are interesting or exciting to us. The teacher's job is to construct lessons that connect to the learner, relating what is to be taught to the students' lives can accomplish this.
- 2. Memory, is the complex process that used three system to help a person receive, use, store, and retrieve information. Students who have difficulty with memory, may need directions both orally and in written form, and giving examples of what is expected can help all students.
- 3. Language, is the primary means by which we give and receive information in school. Problems with language, on the other hand, can affect a student's ability to communicate effectively, understand and store verbal and written information, understand what other say, and maintain relationships with others.

4. Organization, in process and organize information in two main ways: simultaneous and successive. Simultaneous processing is the process we use to order or organize information in space. While, successive processing is what we use to order or organize information in time and sequence.<sup>9</sup>

### 2. The concept of Learning Transformation

The transformation in the world of education makes education not more left behind. The transformation of education can be from the system, curriculum, learning media such as digital technology. These changes can indicate that education is not staying in place but moving in a better and more sophisticated direction, especially in the application of learning media using technology. There have been many technologies used in learning.

The progress of the times it is appropriate for technology to be used as a medium of learning. The existence of these media makes education not stop, education actually continues to grow with the updates that have occurred by utilizing increasingly sophisticated technology. The advancement of the internet resulted in education also having to come forward in order to continue to experience updates. So, the transformation of learning media has benefits for all elements in education, both teachers, students, parents to learn more about the transformations that occur in education, especially the use of learning media by utilizing technology.

Changing in this case can take the form of changing the physical, appearance, condition or condition and function of something, either partially or completely changing. According to Petronella Tuhumury transformation is a change in terms of shape.

# a. Learning Media Transformation

Learning media is a tool in the teaching and learning process so that the information that teachers convey can be received more clearly by students and educational and learning goals can also be achieved. The existence of media in a learning is very supportive for the achievement of learning goals. Media can also give a non-boring impression for students, and make students enthusiastic in learning. There is also another opinion that says that the tools or devices used to convey information or material messages from teachers to students are called

According to Kemp and Dayton quoted by Daryanto explained that the media can make the learning process can take place anywhere and anytime.<sup>15</sup> Seeing this, by using learning media, learning can be done according to the place and time of students and teachers. Learning can be carried out by adjusting the needs and conditions of each student and teacher. Learning can be carried out in their respective places and time that can be adjusted to the needs of students and teachers.

Learning media is a tool or device that is able to help teachers convey learning materials to students, and is able to increase students' enthusiasm in learning. The existence of the Covid-19 pandemic made learning media experience updates so that it can be used anywhere and anytime, one of which is by utilizing the internet network.

Learning media is now transformed more modern, namely using network technology devices, which utilize the internet.<sup>16</sup> The existence of this new media can be used in the world of education as a tool that can carry out

To make education to keep progressing and not lagging far from other countries, education needs to undergo transformation.

In the world of education, online education is the use of online technology for teaching and learning (distance learning and e-learning). It will play a very important role and is projected to grow and develop in the future. Online education in its various forms is probably the most promising avenue to improve the quality of education. Learning using technology will make education progress and is expected to be able to achieve educational and learning goals. So, it can be concluded that the transformation of learning media is a change in the shape, appearance, function of learning media from one to something else due to certain factors.

- 2. Updates in online learning using online education media are expected to improve the quality of education and provide new things that can achieve educational goals.
- 3. Develop the student's educational domain. Advanced technology is utilized education for the learning process. The Internet helps create a virtual classroom or online learning where motivating students who are afraid to talk to other students can eliminate their fear. In online learning students are trained to express their opinions as much as possible and get used to being kind to respect the opinions of others, this can develop the cognitive, affective and psychomotor domains of students. The above explanation can be concluded that the use of learning media needs to involve sophisticated

## a. Understanding the Covid 19 Pandemic

A pandemic is an outbreak that spreads to all corners of the world, where it is a problem for the citizens of the world.31 Pandemic is an outbreak that infects a large area due to certain diseases, and the disease can be transmitted. The outbreak is a coronavirus disease commonly called covid 19, the transmission of this outbreak is very fast and difficult to recognize in people who have been infected with this virus.32 Based on the Decree of the Minister of Health of the Republic of Indonesia Number Hk.01.07 / Menkes / 413 /2020 concerning guidelines for prevention and control of coronavirus disease 2019 (Covid-19), that Coronavirus Disease 2019 (covid 19) is an infectious disease caused by a new type of coronavirus. The disease began with an unknown case of pneumonia in Wuhan, China at the end of December 2019. The pandemic had a huge impact on the lives of many people. According to Rothan & Byrareddy quoted by Ali Sadikin and Afreni Hamidah, the Covid 19 Outbreak is a type of outbreak that attacks the immune and respiratory systems of humans and its spread takes a short time.<sup>20</sup> Coronavirus is a large group of viruses that can cause diseases with mild to severe symptoms, now activities involving the community began to be restricted, such as going to school, working, worshiping. The

Based on the Decree of the Minister of Health of the Republic of Indonesia Number Hk.01.07 /Menkes/413/2020 concerning Guidelines for prevention and control of Coronavirus Disease 2019 (Covid-19), to reduce the transmission of covid 19 people are prohibited from crowding or gathering. To maintain each other's health and efforts so as not to get infected, it is recommended to regularly exercise, wash hands, wear masks, and stay away from crowds. Because if a person is exposed to covid 19 then others have a chance to get infected, especially people around him.

#### b. Implementation of Learning during the Covid 19 Pandemic

The issuance of Circular Letter No. 4 of 2020 by the Minister of Education and Culture (Mendikbud) on the Implementation of Education Policy in the Emergency Period of the Spread of Corona Virus Diseases-19, where the implementation of learning to be carried out remotely or online to avoid gatherings or crowds so that Covid 19 does not spread further. Learning to change from what usually takes place in the classroom, now takes place in the network using a mobile phone. On the other hand, online learning results in teachers having to master technology to create the learning media that students need. Teachers are required to be creative so that online learning becomes lively and students feel not bored.

However, not a few teachers are still familiar with technology. Another impact experienced by teachers is that teachers who usually interact directly with students and other teachers in school, are now faced with learning from home makes teachers bored and many temptations from homework that must be done.<sup>22</sup> More or less teachers have the task of taking care of the house without being helped by a household assistant. According to Pujilestari quoted by Ricka Tesi N. and Zulela MS, one of the impacts of the Covid-19 pandemic is the transformation of technology in the field of education, especially the elementary school level. The existence of online learning, technology is the key to the course of online learning. 37 Seeing that, the Covid-19 pandemic has become a new impression on learning because at first there has not been much learning that uses technology as a Media, now learning using digital technology, such as mobile phones that utilize the internet network. Teachers must be good at utilizing emerging technologies to be used as a learning medium. Technology products that can be used as a learning medium during the Covid-19 pandemic are computers or mobile phones, because these two products are able to bring something far apart. However, basically every learning medium has its own advantages and disadvantages.

According to Government Regulation of the Republic of Indonesia Number 21 of 2020 concerning Large-Scale Social Restrictions in the Context of Accelerating The Handling of Corona Virus Disease 2019 (Covid-19), that to stay away from crowds, large-scale social restrictions (PSBB) are established. This is related to the establishment of online learning, so that school residents and people around become

Looking at the above provisions, relevant to the Guidebook for The Implementation of Learning in the 2020/2021 School Year and the Academic Year 2020/2021 during the Coronavirus Disease 2019 (Covid-19) Pandemic was decided by 4 ministers, namely the Minister of Education and Culture, the Minister of Religion, the Minister of Health, and the Minister of Home Affairs, explained that in mid-April 2020, the Ministry of Education and Culture also aired the Learning from Home (BDR) program broadcast by TVRI. This broadcast can be watched by all Indonesian people, from early childhood to college. With different residual charges adjusted to the level.

The current condition of the Covid-19 pandemic has resulted in education where it is forced to transform to adapt to distance learning that utilizes online media in their respective homes. The solution, teachers are required to create innovative learning media by utilizing online media..<sup>23</sup>

The limitations of distance learning carried out online, overcome by the need for media that if it can cause interaction between teachers and students so that learning is more effective and efficient. The main learning media at the beginning of distance learning is modules, but as technology develops, learning media comes with the help of computers, audio, media instead of print, multimedia, internet.

The online learning process relies on technology in delivering materials as a virtual learning platform. Various online media applications that must be mastered by

- f. Evaluation.



- a. Determine to whom the interview will be conducted.

- c. Initiating or opening the interview flow.
- d. Inform a summary of the results of the interview and end it.
- e. Write the results of the interviews into field notes.

#### 3. Documentation

Documentation is a data collection technique that is a way to obtain information from various written sources or documents that exist in respondents. In this case the document serves as a data source, because with the document can be utilized to prove, interpret and forecast about events. The use of documentation in this study is directed by research to document important matters related to nausea. Therefore, data collection techniques with documentation are very supportive of the research process. ## F. Data Validity Test

The depenability test mechanism can be carried out through an audit by an independent auditor, or a supervisor of the research process series. If the researcher does not have a track record of his research activities then his dependability can be doubted.

## G. Data Analysis Techniques

Data analysis includes many activities, namely: categorizing data, organizing data, data manipulation, summing data, which is directed to obtain answers to research problems.

For this research study using qualitative descriptive analysis techniques with miles and Humberman data analysis model approaches, namely data reduction, display data, and consulusions drawing / verification data.

#### 1. Data Reduction

Reducing data means to summarize, choose the basic substance, focus on the important substances, find the theme and the pattern, and dispose the unnecessary. There are many data collected from the observation, and interview In this research, the researcher limited only to the descriptionstudent's strategies in managing tension toward speaking class during covid-19 pandemic at sixth semester of English Education Program. Based on the explanation above, the researcher give some question about the process of the learning activities, the first question is answered by the teacherr, it stated that: "Learning activities in this class always by using discussion method, the materials delivered by teacher at whiteboard and also gives the materials for students" <sup>31</sup>

Based on the resulf of interview above, the researcher again explained the result of interview for another informant stated that:

"This class always devided into several group of students, than we explain the materials, also asked the students to memorize some vocabulary and asked them to write some task" 32

Another informan also stated that:

"For the clas, we devided the students to some group and they will discuss for the materials, and will write the text based on the task given for them"<sup>33</sup>

The researcher explained more about the activities at class after pandemic covid-19, based on the observation and result of interview, the researcher believe that, discussion method is the method followed by the teacher at Boarding School Nurul Azhar Talawe Kab. Sidrap after pandemic.

Applying discussion method is more effective argument by the teacher at Boarding School Nurul Azhar Talawe Kab. Sidrap, the teacher express enjoyable to do discussion method even for giving any task to the student's or just explain the materials for the students at class.

"Before pandemic situation, many students get materials based on the group divided and the group would be discuss one another, the students showed many improvement before learning in covid-19"34

According to the basic explanation of the discussion method. Discussion methods are a variety of forums for open-ended, collaborative exchange of ideas among a teacher and students or among students for the purpose of furthering students thinking, learning, problem solving, understanding, or literary appreciation.

"Students respnd very good before pandemic, after pandemic also they pay attention to the materials that taught at classroom, many students undertand materials", 35

Discussion method may become the main method using for the teacher at Boarding School Nurul Azhar Talawe Kab. Sidrap, it assumed that, teacher belive about the important using discussion method for improving students English capability at class.

"The strategy we used in teaching English at class was using discussion strategy; It may improve the students' English interaction"<sup>36</sup>

The students' English processed before pandemic was using discussion approach with also identified used after pandemic at this school. The method used by the teacher was not different between before and after pandemic.

"We used same method in English teaching before and after pandemic situation" <sup>37</sup>

If the researcher observe the students respond at the class, the students can simply give re-sponses in verbal and written forms of a situation in their worksite by using discussion term. Unfortunately, some of students do not realize how important English is afte observing th estudents responses. It can be observed that they get low scores on English tests. They have to join a specific remedy to improve their scores. Several students have to enter the second remedy because their scores are still insufficient.

Based on the students statement that:

"Its better for me to study in covid-19 but also we cant understand the matery given by the teacher" <sup>38</sup>

Another students stated also that:

"For me, online is good but we cant meet with our friend and cant to learn together, its good also if we study like now face to face to the friends" <sup>39</sup>

Based on the answered above, the students belive the discussion method is more effective to be applied at class, the teachers should be able to apply methods that can motivate students to learn English more and make them actively involved during the instructional activity. Discussion is one of the exciting methods that can be put into practice, promoting a dynamic interactive classroom and substituting individual learning with group learning. It can be inferred that the discussion method is an exciting method that can make students actively involved during the instructional activities.

"The transformation that I fell during pandemic and aftert pandemic is only about the using of media visual like, LCD, power point and some of the other aid learning that is very powerfull for the students" <sup>40</sup>

The students can explore their English skills during the discussion; they can improve their English ability by sharing ideas and experiences with others. Another question giving to the teacher at class is about the emedia using during the class, the media is used for the class is LCD, LCD helped the students' to illustrate the materials giving, more visual helped the students'.

"This class always prepared LCD for helping students' in their visual materials, the materials assumed more easy to undertanding by using LCD"<sup>41</sup>

Based on the statement of the informant, the researcher sums that media may help the students in their interest, students' be more focused in doing learning activities at class which using LCD. Based on the observation and trough interview result, the researcher can conclude the research question number one which the processed of the learning activities, the method using at class is discussion method which followed the curriculum and using media for learning.

2. The students outcomes after pandemic covid-19 at Boarding School Nurul Azhar Talawe Kab. Sidrap

The second research question refers to the students outcomes after pandemic covid-19 at Boarding School Nurul Azhar Talawe Kab. Sidrap, the students' outcomes get from the interview and asking the teacher directly for the students and teacher performing.

Several students asked for the first question, the question refers to the students outcome before and during pandemic covid-19, she stated that:

"Students' get difficult in undertanding materials, the materials which delivering by online look hard to be understood by the students', it may assumed that, online learning approach was not really effective to be applied at class",42

Based on the statement above, Learning activities is important in learning a language to be able to interact well; teacher and students who were active were needed. The teacher were active in practicing English in classroom and giving interactive activity in class. The students were active in practicing their English ability, by asking questions or expressing their idea/opinion. Both the teacher and the students were important actors to make an interactive English class. The students showed some difficult and showed also some active interaction during learning activities at class.

"There are several adventages I fell during learning after pandemic, that is the media and the class become very interesting because we using Handphone when we learn, so its good to learn', 43

Based on the observation trough class activities, some students never expressed their own idea/opinion. They were obedient to the lecturer. It seemed that they did not have any other literature. They only relied on the teacher. The communication between the student and the teacher was limited on asking about English words. Asking about class activity instruction or material was not found. If the students asked questions to the teacher, they did

Another statement from the teacher that:

"Students' showed low performing from their outcomes learning at class since the pandemic class, it caused of many factors, some of the factors can be clasified were about the healthy and also accesssed of the elearning".

Based on the statement above, the teacher argue that, students' showed low outcomes from the statement of the teacher, outcomes which identified in this research was about the students performing at class in english subject et all. Many students' showed bad performing before and during pandemic situation on online learning. The materials can not delivered well among the learning activities.

"For me, I like to study before pandemic, because we can explor many things and also we can meet with our firend better that we study when its covid-19" 45"

Some of the question refers to the total students which finish the final test before the pandemic covid-19, the researcher asked the question for that, final score which asked to the teacher aswered by simple answered that:

"Students' can not be tested effectivly in pandemic, the teacher did not given test for students because is not really effective to evaluate in online situation".

Based on the statement above, the researcher can not evaluate the students effectively, but in summary, the result outcomes for the students in english materials learning online in pandemic was low performing.

Based on the statement another informan that:

"Students learning outcome after pandemic was good enough, the transition of the learning approach from online approach and offline approas was more effective in offline learning".

Based on the statement above, the researcher belive that, more effective in learning after pandemic, if the students and teacher mention how hard the students' and teacher doing learning pprocessing at class, it assumed that, more effective to learn in offline face to face learning.

According to the result interview that one technique to make the students more active that was done by the teacher was by pointing/calling the students' name one by one in doing class activity or practicing dialogue. The students were rarely found. If the teacher pointed to one student to do an activity, he did it. But, if the teacher gave time for the students, the students were silent. When asking the students, the teacher usually gave more chanceto the students who had understood the material first. The students were regarded as the model for others.

Based on the result of observation, the communication that happened among the students was about asking difficult English and practicing dialogue/activity after during pandemic covid-19 at Boarding School Nurul Azhar Talawe Kab. Sidrap. The students showed more easily, students' asked

Based on the students statement that:

"We as a students fell better in learning ofline face to face to the students, because better in learning ofline than online since we learn by online in pandemic situation",48

Based on the statement above, another statemenst which related to the beneficant of the textbook guidence in learning english. The students' book was only the textbook from collage when they learning English, the students' would ask their friends or teacher.

Some of the question also related to the ole of the teacher in learning after pandemic covid-19, The role of the lecturer in classroom was very important in the success of the English Learning activities. What happened in class was usually influenced by the teacher role. The class activity was determined most by the teacher. The teacher should be more often speak in English, so that the students become more usual. The teacher role is as a mediator. Students' explains the topic and practices more.

The observation adn interview also do for the students, most students understand the materials which delivered by teacher after pandemic covid, the transformation of the processed support the students' in learning english because most of the students' showed great outcomes after learning by ofline approach.

Based on the result of data, the researcher sums that transformation of the study at Boarding School Nurul Azhar Talawe Kab. Sidrap identify for method and approach which outcome much better than before pandemic covid-19.

#### **B.** Discussion

 The learning process before pandemic covid-19 at Boarding School Nurul Azhar Talawe Kab. Sidrap.

This result fo data connected with the result befor, the researcher explained more about the discussion that referred to procees before and after pandemic covid-19 at Boarding School Nurul Azhar Talawe Kab. Sidrap, learning processed. The condition of the English class was conducive. The students had good performing to the teacher but in fact, before learning in covid-19 situation. The students did not really like learn in covid 19 situation.

Students did pai attention to the teacher when the teacher explained the material. The students are quite good in giving attention, some of them are not or noisy. But, they do the activity or practice the dialog, the students learned English both in classroom, the students were active when they were studying in the class. The students who are inactive in class and also they are not interested in class. Usually, the students are more active in real class.

Based on the observation the teacher showed role as is the mediator. the students who do not understand the materials expressed their confusing at class better in offline class. The teacher be able to motivate the students to be more active. The teacher should be able to become a model for his student's students.

Teaching at class by discussion method which implemented by the teacher hepl the students so much at class. Based on the result data above, The students know about the english materials concept at class for students Boarding School Nurul Azhar Talawe Kab. Sidrap. It was the result for observing in English materials at class. to make the students understand. Another important role of the teacher is as the learning method using at class. Students' gave another students' motivation or made a condition so that the students were motivated to study by offline like the situation among the time at after covid-19. By having good communia, the students would learn better. The participation from both the lecturer and the students were needed to make the class goes smoothly and successfully.

2. The students outcomes after pandemic covid-19 at Boarding School Nurul

Azhar Talawe Kab. Sidrap

Students outcomes become the second research question, students' outcomes which identify for the most important thing in order to get resulf on how effective the transformation of the teaching english during covid—19 and it's after covid-19.

The transformation in the class referred to the method, the transformation of from the system and learning media such as digital technology transform to the face to face which exploit also digital like LCD and some other media. These changes can indicate that education is not staying in place but moving in a better and more effective, especially in the application of learning media using technology. There have been many technologies used in learning after pandemic covid-19.

The transformation of learning media has benefits for all elements in education, both teachers, students, which effective to be more effective even in learning activities or students outcomes. Learn more about the transformations that occur in education, especially the use of learning media by utilizing technology which LCD.

Based on the explanation above, the transformation of the education force the learning activities of school to be more adopted the regulation of ofline system after pendemic. This also related to the media transformation toward the system at school which more using visual media.



#### **CHAPTER V**

#### CONCLUSION AND SUGGESTION

#### A. CONCLUSION

Based on the result of discussion about transformation of English Learning after Pandemic Covid-19 toward Students Outcomes at Boarding School Nurul Azhar Talawe Kab. Sidrap, it can be concluding that:

- 1. The learning process before pandemic covid-19 at Boarding School Nurul Azhar Talawe Kab. Sidrap showed that, learning processed followed the regulation of the curriculum which using discussion method and some media interactive like LCD for developing students' English performing at class. Learning approach to the students' interactive and communication matter.
- 2. The students outcomes after pandemic covid-19 at Boarding School Nurul Azhar Talawe Kab. Sidrap showed that, students' outcome after covid-19 showed good English performing which mostly get more than KKM score clasified from the students' performing in interaction while also for their communication. Transformation trough media and learning activities which better and effective after covid-19.

#### B. SUGGESTION

Based on the conclusion above, the suggestion offer to several person namely:

- 2. Teacher to support more about the using of technology which impact from the covid-19 as transformation of learning media.
- 3. Next researcher to do another experiment to conduct research which related to the transformation of english learning activities.
